## **HUMAN RESOURCES AND BENEFITS**

One of the ways that the Foundation can save money and keep costs low is that there is no human resources department and the project managers are not employees of the organization. Project managers are independent contractors and can chose to be sole proprietors or form an entity for compensation. We work with you to structure a strategic plan that provides for contractor pay, employee pay, healthcare, retirement programs and other benefits that are customized for their situation.	OTHER ORGANIZATIONS  Organizations that have employees usually have a human resources department and offer healthcare retirement programs for their staff. If you need these services, then it is a valuable service but it adds higher organizational costs for administration and all employees must be treated the same and use the same plans.

## **CUSTOM MINISTRY DESIGN**

You can have a project under the Foundation, a separate 501(c)(3), a ministry services entity, a supporting organization or simply contract for services ala carte. Your structure depends on what works best for you and the Foundation.	Most organizations limit the ways that programs can operate under their structure so that the administration is efficient and easier to manage for the administrative staff. This is especially true if you are required to be an employee of the organization.



#### **BUSINESS AS MINISTRY OR BUSINESS AND MINISTRY**

At the New Horizons Foundation, we specialize in helping people who want to work part-time or in their spare-time as well as people who want to work full-time. Since you are not an employee of the Foundation, you can integrate business and ministry together without causing problems for the organization. The Foundation pays for charitable ministry and so can be a great partner to existing businesses and businesses that have a dual purpose of profit and charity.

#### OTHER ORGANIZATIONS

Most organizations have employees and those employees must be treated equally. When staff are employees and have a business or work in a business then problems can occur. Organizations must be careful not to have employees paid twice for the same work, by the organization and by the business. There is also often not a model for how business profits or investors will be treated. It often puts the ministry in a position of having liability and having to monitor and advise a business in the US or abroad which is outside their expertise.

# IMMEDIATE ACCESS TO YOUR IMPORTANT DATA FROM ANYWHERE IN THE WORLD

#### NEW HORIZONS FOUNDATION

The New Horizons Foundation offers separate project management that allows project managers to see all of their relevant financial information, file for expense reimbursements and file organizational reports related to a project, along with access to complete donor information from the web 24/7. There is an organizational help desk with FAQs and a ticket system for any problems or specialized needs that occur. The structure is designed to service individual projects.

## OTHER ORGANIZATIONS

Larger organization offer project managers access to information on the web 24/7 where they can find relevant financial information, file for expense reimbursements and see donor information. The structure of the system is usually designed to provide accurate data and efficiency for the organization's administration staff and not for the individual project managers, so reports and specialized services can be difficult.

#### **CANADIAN DONATIONS**

Because of the difficulty of having Canadian donors get a charitable tax deduction for gifts to US charities, The New Horizons Foundation has a partnership with a sister organization in Canada that is operated very similarly to the Foundation. This allows Canadian donors to donate to New Horizons Foundation projects without additional costs and fees.

# OTHER ORGANIZATIONS

Many US charities do not have the ability for Canadian donors to receive a Canadian tax receipt for their gift to a US charity.

Larger organizations will have set up an entity in Canada that can receipt Canadian donors for their gifts, but there is often an extra fee for these donations.
