

Fiscal Sponsorship

Fiscal sponsorship is a cost-effective way to implement new programs, bring together groups to collaborate on an issue, keep administration expenses low and test new approaches to social change. Fiscal sponsorship is a common mechanism used in the nonprofit sector that enables individuals to start new programs without establishing a new, separate nonprofit tax-exempt organization. These fiscally sponsored projects get their charitable status from their fiscal sponsor. Fiscally sponsored projects of the New Horizons Foundation are not separate and isolated entities; rather they are an integral part of New Horizons. We receive charitable donations and grants on behalf of our fiscally sponsored projects; maintain the necessary legal and financial infrastructure for all project activities and allow project managers to focus on creating a healthy, just and vibrant world.

The New Horizons Foundation provides fiscal sponsorship to several types of projects that operate under the Foundation:

Operating Projects

An Operating Project is the vehicle wherein an individual, group of individuals, or family can partner with the Foundation to accomplish their charitable desires allowing them to "take their vision to the world." An Operating Project offers the opportunity to put feet to a vision! New Horizons Foundation, Inc allows individuals the opportunity to fulfill their charitable vision without the time and expense of obtaining their own tax-exempt 501(c)(3) status.



Donor Advised Funds

A Donor Advised Fund (DAF) is a charitable giving vehicle wherein an individual, family or corporation makes an irrevocable, tax-deductible contribution of personal assets to a charity and at any time thereafter can recommend grant distributions to qualified charitable organizations. A DAF is a great way to help individuals, families, and corporations achieve their desire to take their "vision to the world" for a charitable impact. A DAF offers the opportunity to create a low cost, convenient, efficient method of charitable giving while maximizing tax advantages. Contributions made to a DAF not only aid current tax planning, but provide the opportunity for additional funding from the estate by a will bequest, charitable trust, gift annuity, or insurance policy to ensure your vision for charitable impact is taken to the world for years to come!

Field of Interest Funds

Field of Interest Funds will be established by The New Horizons Foundation Board of Directors as supportive to the purposes of the organization. Each Fund has an advisory board that is appointed by The New Horizons Foundation Board of Directors to oversee the operation and distributions of the Fund. Donors may give specifically to these Funds and know that their money will be used for the purpose established by each Fund. The following current Field of Interest Funds have been established to serve specific purposes in the Foundation:

- THE FOREIGN MISSIONS PROGRAM This Fund has been established to oversee foreign missions experiences for donors and other volunteers who want to travel oversees to work on or evaluate mission projects. Applicants will submit an application along with a budget for their mission trip to be approved by the Fund advisory board and then file a project report when they return. Once approved, donors may give money directly to the Fund or transfer money from their Donor Advised Fund, Supporting Organizations, Private Foundations or Charitable Trust to pay for the trip or they can raise the support from donors.
- THE MINISTRY ASSOCIATES PROJECT This Fund has been established to provide an opportunity for individuals to raise support and be paid for work they do for recognized ministries or approved charitable projects as independent contractors. Contractors must submit an application with an approved job description, set of responsibilities, hours



of work, budget and a designated supervisor with an approved ministry or onsite project. The contractor and supervisor must submit quarterly reports to the Fund on the work done by the contractor. Funds can be raised by projects to pay for these services.

- THE MEDICAL/BENEVOLENCE FUND This Fund has been established to make gifts to qualified applicants who have documented medical or benevolent needs. The advisory board will review applications and award grants based on the money that is available in the Fund. Donors may transfer money from their charitable entities or Donor Advised Funds to fund the grants that will be made to approved applicants. The program will be publicized on the Foundation's website with the appropriate forms and be available to the general public.
- THE NATURAL DISASTER FUND When natural disasters like floods, fires, earthquakes, hurricanes etc. strike, an emergency project can be set up immediately to provide assistance to victims. Many times, these gifts are received for "where needed most" depending on the greatest need. A committee of the board serves to clear requests for donations and get the resources to those in need.
- **SCHOLARSHIP FUNDS** If you are interested in creating a scholarship fund, an Educational Assistance Fund can be established to administrate funds to award Scholarships. Due to some of the complexities and tax issues related to scholarship administration, special procedures have been established to meet the IRS guidelines to keep the scholarships tax free to students.

Legacy Projects

Legacy Projects are projects that will be funded from future gifts to the foundation. Gifts from wills, trusts or estates, remainder gifts from Charitable Remainder Unitrusts, gifts from insurance policies or insurance trusts, terminations of private foundations, etc. When The New Horizons Foundation is named in one or more of the agreements mentioned, a future project will be established with the information from the Donor requesting how they would like the funds to be used in the future and who might be the Managers of the project when it is funded.
